**\*\*\*[HB 1291](#) – This bill will be heard by the [HOUSE Special Committee on Housing](#) on **02/16/2024 at 02:30 PM in LOB 302-304. This is the bill that resurrects HB 44 and will decimate our remaining Single-Family neighborhoods.** You may attend and speak at the hearing or register your position online.
